GENERAL CONDITIONS

1. Stands Assembly:

All materials intended for use in exhibition stands must be the characteristics designated by AERO EXPO SAC. Any changes must be approved by **AERO EXPO SAC** with no least ninety (90) days before the event.

2. Assembly and Disassembly of Exhibitor Stands.

Installation and Assembly

November 12th to 15th, 2018 (8:00 a.m. to 5:00 pm).

Disassembly:

November 19th, 2018 (8:00 a.m. to 5:00 pm).

3. Date of arrival and departure of aircraft:

Given the nature of this agreement, the exhibitor undertakes that its aircraft landing in the later than 4:00 pm of november 15th, 2018 Las Palmas Air Force Base, (SPLP) and Take Off from Las Palmas (SPLP) november 18th later 4:00 pm. The Exhibitor expense all permits and authorizations Charges. During aircraft parked, unless authorized by **AERO EXPO SAC** will remain in the allocated stands

4. Landing Fees and Ground Support

All charges to the exhibitor for Demo take offs and landings and charges incurred by the use of ground support equipment such as tow bars or external power units established by the

Peruvian Air Force (II RAT), which will be send the invoice of all the charges to the exhibitor handler.

5. Cancellation or Reduction of stand Exhibition

In the event of a cancellation of the exhibition, the exhibitor must notify in writing in advance of (120) days before the start the event. In this case **AERO EXPO SAC** will retain a charge equivalent to (50%) percent of the cost of the stand.

If cancellation occurs within (120) days from the date of the show, the exhibitor will paying 100% of the cost of the stand.

6. Stands

Due to the need to allocate stands and according to the terms of this contract, require a deposit of at least (50%) percent of the value of the stand for separation, which will be accompanied by his respective contract and must be paid in full no later than October first 2018.

Failure by Exhibitor's payment is considered a cancellation.

AERO EXPO SAC has the authority to prohibit the participation in the event

Reserves stands will not acceptance unless the contract has been paid the full (100%) of the cost of the stands, which can be installed at the time **AERO EXPO SAC** confirm the payment

7. Interruption or Termination of the Exhibition.

In fortuitous case or disaster, the event not made the **AERO EXPO SAC**. The exhibitor is not entitled to compensation or claim of any kind

8. Liability and indemnity

Is responsibility of the exhibitor will have all the authorizations, patents and permissions and any other requirement that is necessary and enabling for the exhibition of their material or services inside the fairgrounds and **AERO EXPO SAC** exempt of any responsibility . The Exhibitor undertakes in this Agreement to comply with the designated above.

Exhibitor. Releases of this Agreement has **AERO EXPO SAC**. Any civil, criminal or administrative liability eventually generated due to accidents or incidents, of what ever nature, arising from their participation in the event, either affect your personal, other exhibitors or third parties that visit the fairgrounds.

9. Regulation:

Exhibitor. Shall comply with Peruvian legislation on everything related to your participation in the event.

Exhibitor. Declares to know and accept in its entirety the general rules of **Aero Expo Perú 2018**, which is part of the agreement part and, therefore, undertakes to respect during their participation in the fair

Disclaimer: If for unforeseen circumstances or force majeure is not effected the AERO EXPO PERU 2018. The exhibitor is not entitled to compensation or claim of any kind

Entry into force: This Convention came into force once signed by the parties and shall remain in force until fully compliance with the obligations contained in the. However, **AERO EXPO SAC.** Will be entitled to their early termination of the right in the following cases:

- ° By any breach of the obligations assumed by the Exhibitor in this agreement.
- ° By demanding it the public interest or National Security

Competition: Disputes that may arise between the parties for the interpretation, application and implementation of this agreement, they will be resolved in harmony, through direct negotiations. In the absence of agreement, the dispute in question will be submitted to understanding and resolution of the Courts and judges of the city of Lima Peru.

10. Insurance

The Exhibitor must take insurance from accidents and civil damages against third parties, which shall attach a copy of the policy of insurance coverage.
