## **AGREEMENT TO RENT EXHIBITION SPACES**

### **1. BOOTH ASSEMBLY:**

All suppliers implementers of exhibition booths must be accredited and authorized by **AERO EXPO SAC** must be have insurance policy for general risks and liability for third party endorsed to **AERO EXPO SAC**. Any Modification will be notify 90 days before start the event.

### **2. ASSEMBLY AND DISASSEMBLY.**

#### **ASSEMBLY DATE.**

From November Monday 12 to Thursday 15, 2018 (9:00 a.m. to 5:00 pm).

#### **DISSASSEMBLY DATED.**

Monday, November 19, 2018 (9:00 a.m. to 5:00 pm)

### **3. CANCELLATION OR REDUCTION.**

In the event of a cancellation of the exhibition, the exhibitor must notify in writing in advance of (60) days before the start of the fair. In this case, **AERO EXPO SAC** will retain a charge equivalent to (50%) percent of the cost of the stand.

If cancellation occurs within (60) days from the date of the show, the exhibitor is responsible for paying 100% of the cost of the stand.

### **4. BOOTH PAYMENT.**

Due to the need to allocate stands and according to the terms of this contract, requires a full 100% deposit of at least October 16

**5. FAILURE OF PAYMENT:** If **THE EXHIBITOR** does not pay the rented in the established dates previously, this agreement will be canceled, forthwith and as a matter of right, entitling **AERO EXPO SAC** to release the rented spaces and without refund of the payments made by **THE EXHIBITOR**, as a clearance for the breach of contract.

#### **6. WAIVER.**

In fortuitous or force majeure, not made the **AERO EXPO SAC**. The exhibitor is not entitled to compensation or claim of any kind

#### **7. RESPONSIBILITY**

It will be the sole responsibility of **THE EXHIBITOR** to have all the authorizations, licenses, permits and any other requirement that will be necessary and qualifying for displaying your exhibits and/or services inside the fair venue, releasing **AERO EXPO PERU 2016** of any liability about it. **THE EXHIBITOR** commits himself in this act to fulfill the abovementioned.

#### **8. TERM.**

The present agreement will enter into force once it is signed by both parties and it will rule until there are fulfilled fully the obligations herein. However, **AERO EXPO SAC** is entitled to end it in advance, as a matter of right, in the following cases:

- ° for failure of any of the obligations assumed by the exhibitor herein.
- ° for demand of the public interest or national security.

#### **9. JURISDICTION:**

Disputes that may arise between the parties for the interpretation, application and implementation of the present agreement, they will be resolved in harmony, through direct negotiations. In the absence of agreement, the dispute in question will be submitted to understanding and resolution of the courts and judges of the city of Lima Peru.

**10. LEGAL REPRESENTATION:**

The person that signs this agreement on behalf of **THE EXHIBITOR** certifies that acts with enough legal Representation to subscribe it, so in the event that this circumstance is not effective, the party to an instrument is personally responsible Of all the obligations assumed pursuant to the present agreement.

**11. GENERAL SALES TAX. (IGV)**

**AERO EXPO SAC** is obliged to charge the general sales tax (IGV), 18% of the sale price, which will be included in the invoice.
